Why Compliance Still matters?

The **FMCSA** continues to tighten regulations, and carriers with missing documentation or outdated programs are more likely to face audits, fines, and even shutdowns. This guide gives you practical steps to stay ahead of those risks.

Key Compliance Areas to Cover

- ✓ **Driver Qualification Files:** Must include up-to-date medical cards, MVRs, and signed application documents.
- ✓ **Drug & Alcohol Testing Program:** Ensure you are enrolled in a compliant random testing pool, and that all new drivers are pre-employment tested.
- ✓ **Clearinghouse Compliance:** Every CDL driver must be registered and queried annually. Employers must be registered and managing violations properly.
- ✓ **Hours of Service (HOS) / ELD Logs:** Review log violations, falsifications, and form & manner errors weekly.
- ✓ **Vehicle Inspections & Maintenance:** Maintain your DVIRs, maintenance records, and fix out-of-service violations promptly



The Top 5 Violations to Avoid

- 1.** Operating without a valid medical card*
- 2.** Failing to conduct pre-employment drug tests*
- 3.** No annual MVR review or driver file audit*
- 4.** Out-of-date ELD settings or unassigned driving time*
- 5.** No documented maintenance records*



Proactive Compliance Steps You Can Take:

1

Set monthly calendar reminders to review driver files

2

Use a checklist to review CSA scores quarterly

3

Assign a compliance contact or program manager

4

Document all actions taken — violations, fixes, training

DOT Quick Self-Audit Checklist – 2025

Use this monthly to ensure you're audit-ready and protected from violations.



✓ **Driver Files**

- All CDL drivers have current medical cards on file
- Driver applications and MVRs are up-to-date
- Annual MVR reviews have been completed and documented

✓ **Drug & Alcohol Program**

- All CDL drivers completed pre-employment testing
- Random testing pool is active and managed
- Test results and documents are stored properly

✓ **Clearinghouse**

- All drivers are registered in the FMCSA Clearinghouse
- Annual queries have been completed
- Any violations are documented and addressed

✓ **ELD & Hours of Service**

- Drivers logs are reviewed weekly
- Unassigned drive time is reviewed and reassigned
- Log errors or falsifications are corrected and trained on

✓ **Vehicle Maintenance**

- All maintenance records are up-to-date
- DVIRs are completed and stored
- Out-of-service items are repaired and documented
